Well will be drilled with rotary tools to top of pay where casing will be set. Pay sand will be drilled with cable tools to total depth of about 3550'.


Well will be sand-oil fractured with 7000 gallons of oil and 5500 pounds of sand.



Scale—4 inches equal 1 mile.


