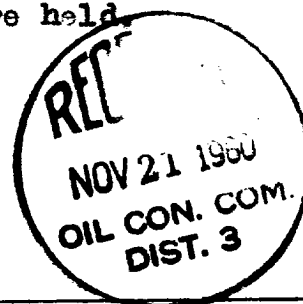

Drilled 11" hole to 105'. Cemented 8 5/8", 24lb. casing at 102' with 50 sacks, 11-3-60. Cement circulated. #OG 18 hrs. Pressured casing to 650 psi. Pressure declined to 640 psi in 30 min., leak in mid line valve. Cemented 4 1/2", 9.5 lb., J-55 casing at 3946' with 150 sacks, 11-11-60. Pressure tested casing to 1500 psi 11-12-60. Pressure held.
