5/25/01 MIRU. TOH laying down 1-1/2" tubing.  
5/26-7/10/01 Fished 2-3/8" tubing, Loc-Set packer and 2-3/8" tailpipe out of hole.  
7/11/01 TIH with 5" packer, tag @ 7466', set at 7356'. Loaded hole with water and pumped into Dakota at 1/4 BPM at 2600 psi. Shut down pump and bled to 0 psi in 30 sec.  
7/12/01 TOH with packer. TIH with cement retainer, set at 7395', could not pump into Dakota. Stung out of cement retainer and spotted 10 sk(12 cu ft) cement plug from 7395'-7283'. Pull tubing to 6690' and spotted a 10 sk(12 cu ft) inside plug from 6690'-6578' as per the verbal approval of Brian Davis of the BLM. TOH with tubing.  
7/13/01 TIH with 191 jts 2-3/8" 4.7# J-55 tubing, set at 6000', seat nipple at 5967'. ND BOP, NU wellhead. RDMO.
