

In an attempt to shut off the water production in this well and increase its production, it is recommended that a liner be cemented from the plug back depth of 134' to approximately 2960'. The producing zone, as indicated on the Gamma Ray Induction Log and Temperature log, will be perforated and selectively sand fraced to obtain production. The well to be cemented with approximately 50 sacks.
