Perforated 4 holes at 2350' (base of Ojo Alamo), spotted a 50 sack cement plug across perms. at 2350' and squeezed.

Shot off 5 1/2" casing at 919', spotted a 30 sack cement plug on top of casing stub at 919', pulled casing.

Spotted a 30 sack cement plug at base of surface casing.

Placed a 10 sack cement plug at surface w/a 4' x 4" P & A marker. P&A completed 10-7-69.

Instructions
