Dear Mr. Gray:

We have just received Gas Well Plat submitted on your #1 Kaine well in the NE $\frac{1}{4}$ Section 20-26N-6W. As dedicated acreage you have outlined the SE $\frac{1}{4}$ NW $\frac{1}{4}$; W $\frac{1}{2}$ NE $\frac{1}{4}$ and the NE $\frac{1}{4}$ NE $\frac{1}{4}$. I believe that Lowry originally made application for an examiner hearing for approval of this non-standard unit on January 24, 1956. I have checked with Mr. Warren Mankin in Santa Fe who conducted the hearing and he states that Mr. Jason Kellahin who appeared for Lowry et al asked that the case be indefinitely postponed as they were hoping to form a standard unit consisting of the NE $\frac{1}{4}$ of Section 20 by communitising with El Paso Natural Gas Company, who owned the SE $\frac{1}{4}$ NE $\frac{1}{4}$.

Therefore the non-standard unit as you have submitted it on your plat has not been approved and we will not be able to approve form G-110 on this well. I would suggest that you check with Mr. Kellahin to see if the communitisation of the NE $\frac{1}{4}$ has been effected and if it has re-submit a plat showing the NE $\frac{1}{4}$ quarter as the dedicated unit.

If we can be of any help to you in the matter, please let us know.
