THE APPLICATION OF NORTHWEST PRODUCTION COMPANY FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS "E" WELL NO. 11-15, LOCATED 1600 FEET FROM THE NORTH LINE AND 1750 PEET FROM THE EAST LINE OF SECTION 15, TOWNSHIP 26 NORTH, RANGE 3 WEST, NOPM, RIO ARRIBA COUNTY, NEW MEXICO, IN SUCH A MANNER AS TO PERMIT THE PRODUCTION OF GAS PROM AN UNDERSENATED PICTURED CLIFFS POOL AND TO PERMIT THE PRODUCTION OF GAS FROM THE BLANCO MESAVERDE POOL.



Under the provisions of Rule 112-A (c) Northwest Production
Company made application to the New Mexico Oil Conservation Commission on April 8,
1958, for permission to dually complete its "E" Well No. 11-15 located 1600 feet
from the North line and 1750 feet from the East line of Section 15, Township 26
North, Range 3 West, NNFM, Rio Arriba County, New Mexico, in such a manner as to
permit the production of gas from an undesignated Pictured Cliffs Pool and to
permit the production of gas from the Blanco Mesaverde Pool.

Now, on this 18th day of April, 1958, the Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Sub-section 'c' of Rule 112-A of the Commission's Rules and Regulations:
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, Northwest Production Company, be and the same is hereby authorized to dually complete its "E" Well No. 11-15 located 1600 feet from the North line and 1750 feet from the East line of Section 15, Township 26 North, Range 3 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to permit the production of gas from an undesignated Pictured Cliffs Pool and to permit the production of gas from the Blanco Mesaverde Pool, through parallel strings of tubing.

PROVIDED HOWEVER. That subject well shall be completed and thereafter produced in such a manner that there will be no commingling within the well-bore, either within or outside the casing, of gas, oil and gas, or oil produced from either or both of the separate strata,

PROVIDED HOWEVER. That prior to the actual dual completion the operator shall make pressure tests of the casing to prove that no casing leaks exist. In the event a casing leak is apparent the operator shall take appropriate steps to adequately repair the leak. The results of these tests shall be reported to the Commission on Form C-103.

PROVIDED FURTHER, That upon the actual dual completion of such subject well applicant shall submit to the appropriate District Office of the Commission copies of Oil Conservation Commission Form C-103, Form C-104, Form C-110, and Form C-122, outlining the information required on those forms by existing Rules and Regulations, and two copies of the electric log of the well.
