17. Describe Proposed or Completed Operations:

9/6/95 Pulled tubing with packer and reverse flow check valve, inspecting for hole in tubing.

No hole was found in tubing. Installed new dual wellhead.

Re-ran 2 3/8" tubing and landed on doughnut at 7611' with 7" Baker R-3 packer set at 4635' for Greenhorn - Mesa Verde production.

Ran 1 1/2" tubing and landed at 2885' for Otero Chacra - Pictured Cliff production.

NOTE: It was determined that we were logging off production from the Greenhorn and Mesa Verde zones through the reverse flow check valve installed above packer. To remedy this problem it was decided to dual complete the Greenhorn - Mesa Verde below a packer and the Otero Chacra - Pictured Cliff above packer. Well is now surface commingled in all four zones at the surface.
