It is proposed to pull 2 7/8" tubing with model R Baker packer and Seal Assy., then go in hole with retrievable packer and bridge plug, locate hole in casing, then repair with cement squeeze jobs.

After repairing leaks and testing casing, 2 7/8" tubing now in hole will be salvaged and two string of 1 1/4" IJ tubing will be run in well to dual complete.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
