"H" + 10% A-10B + 8# sk. gelsonite, followed by 250 sks. "H" + 2% CaCl2. Circulated to surface. PBTD @ 2301'.

Ran CCL & GSL logs. Peforated 2182'-2192', 2210'-2224', 2231'-2237', 2250'-2260'w/2 SPF, total 80 holes. Acidized w/1000 gal. HCL & 128 ball sealers. Frac'd w/70Q N2 foam. Used 400,000 SCF N2, 90,000# 20/40 Arizona sand, 10,000# resin sand.

Set 2 3/8" J-55 tbg. @ 2251'. Put well on 2" x 1 1/4" x 6' x 9' RHAC-Z BHP. Set pumping unit, water tank, separator and compressor. Well turned to sales 9/18/98.
