By letter dated March 29, 1957 application was made for tentative approval to dually complete Well "N" 8-8 in the Greenhorn and Graneros-Dakota formations. Well "N" 8-8 is located in the SW/4 of the SW/4 of Section 8, Township 26 North, Range 4 West, Rio Arriba County, New Mexico.

The subject well was completed March 31, 1957 and shut in for test. On April 8, 1957 a three hour test was taken of the Greenhorn formation. The shut-in pressure at the start of the test was 434#. The well flowed for 45 minutes and died, and did not produce again during the three hour interval.

In view of the non-commercial test of the Greenhorn formation, it is requested that our application for permission to dually complete Well "N" 8-8 in the Greenhorn and Graneros-Dakota formations be voided. By separate letter, however, request is being made for permission to attempt dual completion in the Gallup and Graneros-Dakota formations.
