Reference is made to your letter of September 13, 1956 applying for multiple completion of your #1-7 "W" well in the SW $\frac{1}{4}$ Section 7-26N-35W.

Rule 112 as recently revised does not provide for administrative approval of multiple completion of gas wells, as set out in your letter. The rule as written covers only gas-gas dual completions in the San Juan Basin. Therefore I do not feel that I am authorized to tentatively approve your application as submitted under Rule R-112-C. It will be necessary to make application to Mr. A.L. Porter, Box 871, Santa Fe, requesting that he set the matter up for hearing as soon as possible. I would suggest that you request that he set it for examiner hearing as this can be done more expeditiously.

If you are of the opinion that R-112-C should provide for administrative approval of multiple completions rather than merely for dual completions I would suggest that you make that request part of your application for hearing. In this way future multiple completions might be granted administratively if the order should be amended.
