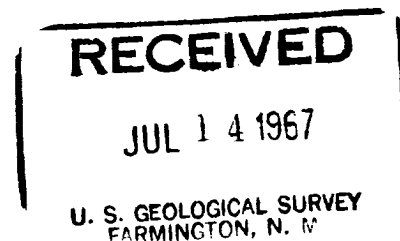

Well has been producing from Dakota, Mesaverde and Pictured Cliff formations since 1956 having been a triple completion. It has recently been found that DK and MV zones have communication. In as much as the DK zone is no longer feasible to produce economically we plan to plug the tubing under the MV zone and continue to produce only the PC and MV. Plan to start Plugging July 9, 1967.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
