On June 8, 1968, we filed with the United States Geological Survey at Washington, New Mexico, our application to drill a Mesquite Apache Shale oil well No. 3, located 1071 feet from the North line and 560 feet from the West line of Section 9, T. 26N., R. 16E., S. 1E., De Baca County, New Mexico. This location was approved by the U. S. G. Lands by his letter of June 8. In our application we stated that our proposed well depth was 8200 feet to reach the base of the Verbe and attempt completion to the Alamo West Venable Reservoir fields.

Since we have just been alerted this well from the National Office at approximately 10:40 to have back as a gas leak, we are attaching revised Form 6-10-10. Request that you send your records accordingly. We are attaching the original and four copies of this letter and five plus, and request that you distribute them to all agencies to which you've copies of the notification.

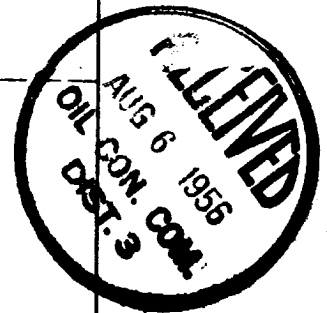
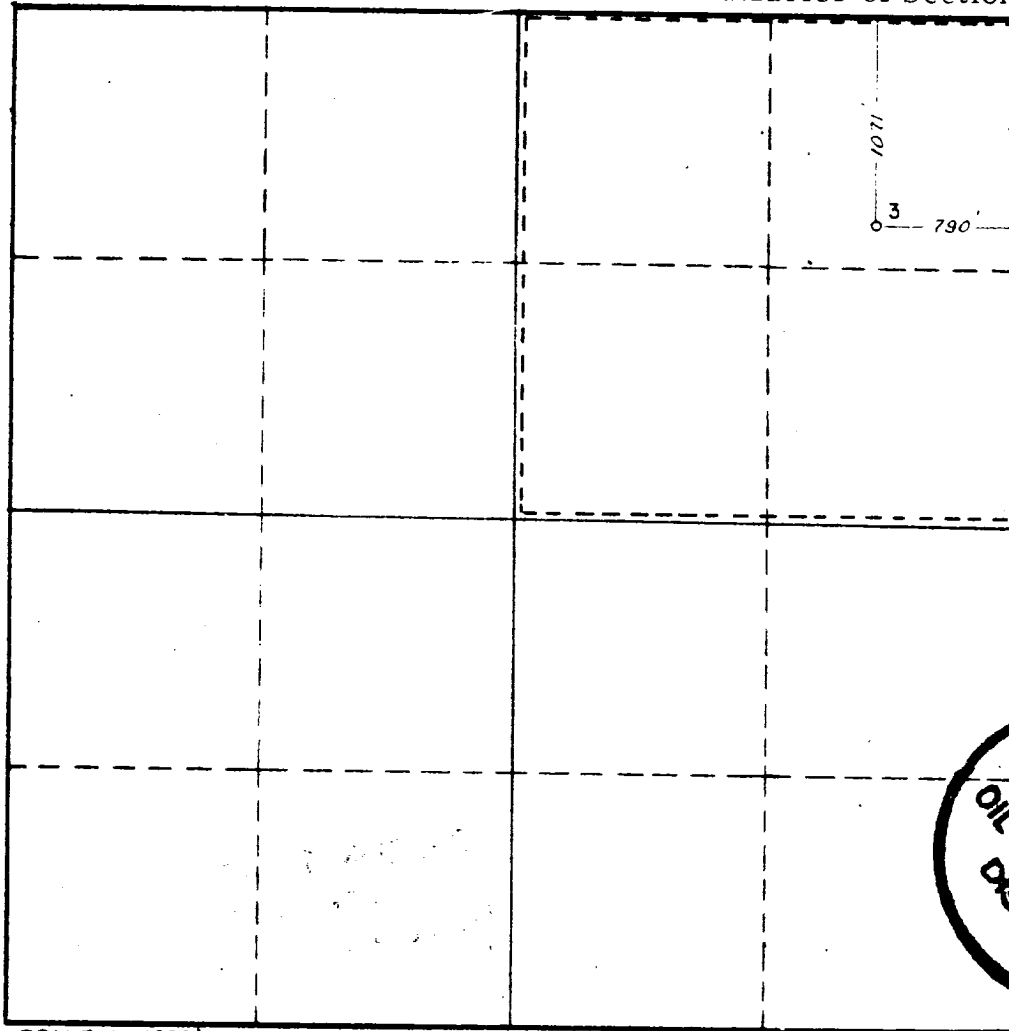
