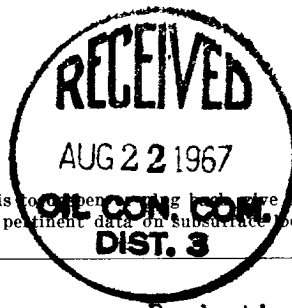

## Instructions

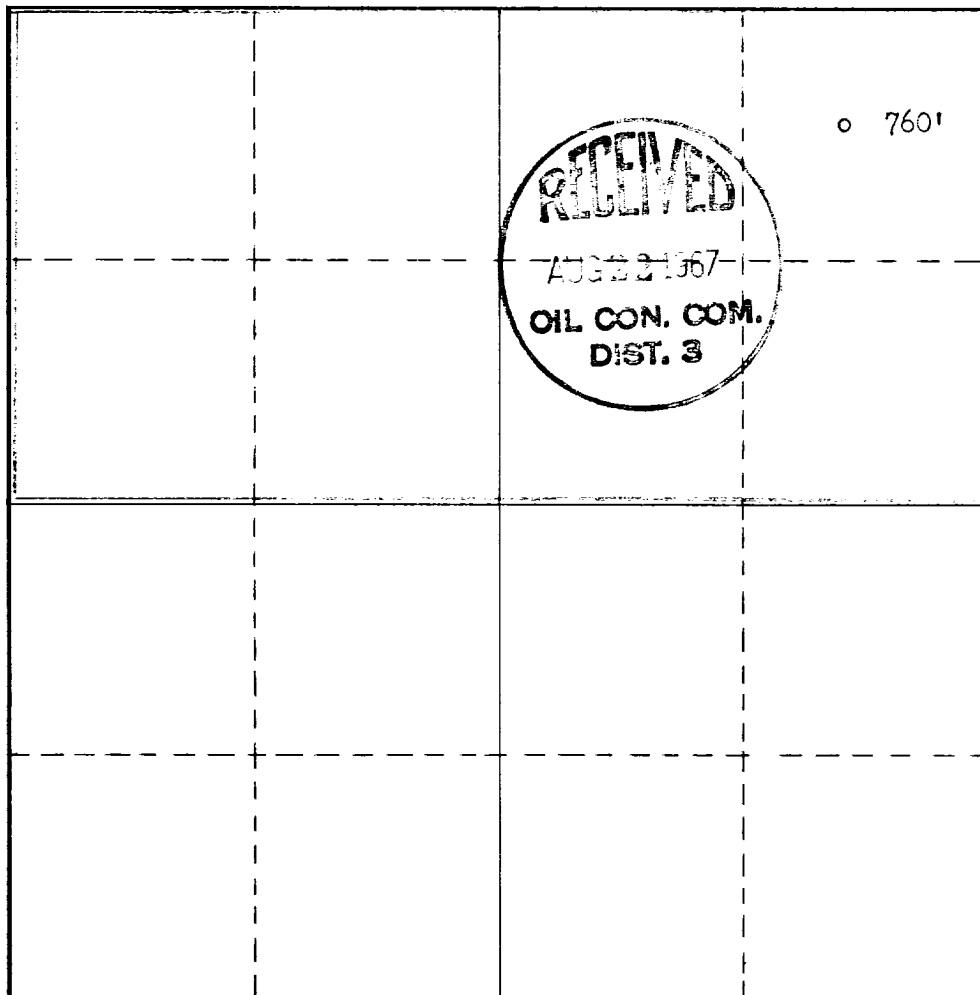
