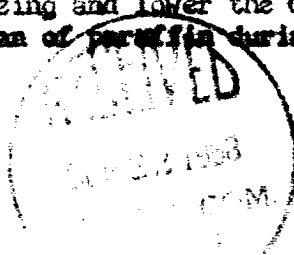

DETAILS OF WORK

On 6/17/58 an Otis type "BW" 8/64" bottom hole choke was set at 6631. A type "F" collar stop was set at 6604 and a 2" type "B" paraffin scraper rabbit installed. The bottom hole choke was run to reduce freezing and lower the GOR. The paraffin scraper was installed to keep the tubing clean of paraffin during the well's normal flow.
