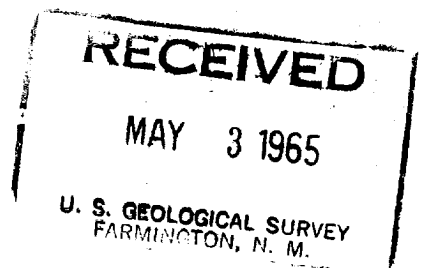

We have found communication between the Gallup zone and the Mesaverde zone on this well. We propose to pull the Mesaverde tubing and pull the Gallup tubing, and Hydrotest the Gallup string. If we do not find a tubing leak we will pull the Dakota string and redress both packers, (Model "D" and Model "J"). Then we will Hydrotest the Dakota string and rerun the three strings of tubing.

Instructions
