

THE APPLICATION OF EL PASO NATURAL
GAS COMPANY FOR A DUAL COMPLETION.
(Tubingless)

ORDER NO. MC-2020

ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 112-A, El Paso Natural Gas Company made application to the New Mexico Oil Conservation Commission on January 26, 1973, for permission to dually complete its Klein Well No. 18 located in Unit J of Section 34, Township 26 North, Range 6 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to produce gas from the South Blanco-Pictured Cliffs Pool and the Otero-Chacra Pool.

Now, on this 13th day of March, 1973, the Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, El Paso Natural Gas Company, be and the same is hereby authorized to dually complete its Klein Well No. 18 located in Unit J of Section 34, Township 26 North, Range 6 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to produce gas from the South Blanco-Pictured Cliffs Pool and the Otero-Chacra Pool through parallel strings of 2 7/8 inch casing cemented in a common well bore.

PROVIDED HOWEVER, That applicant shall complete, operate, and produce said well in accordance with the provisions of Rule 112-A.

PROVIDED FURTHER, That applicant shall take packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test Period for the Otero-Chacra Pool.

IT IS FURTHER ORDERED: That jurisdiction of this cause is hereby retained for the entry of such further orders as the Commission may deem necessary.
