2. Ran IBS and Density logs.
3. Ran 123 joints of 4-1/2", 10.5# casing. Landed at 3998 ft. 4-1/2" stage collar set at 2615 ft. Cemented 1st stage w/250 sacks. Plug down at 1:00 A.M., 10-9-74. 2nd stage cemented w/320 sacks. Plug down at 5:00 a.m., 10-9-74.
4. Moved in completion rig on 11-13-74.
5. Ran tubing and bit and drilled out stage collar at 2615 ft. Cleaned out well to P.B.T.D. of 3941 ft.
6. Pressure tested casing to 2800 psi. Test OK.
7. Ran cement bond and correlation logs.
8. Perforated Pictured Cliffs zone 1 shot/ft. from 3864 ft. to 3894 ft. Total of 30 holes.
9. Sand water fraced perfs w/70,000# sand and 72,000 gallons water.
10. Ran 112 joints of 1-1/2", 2.9#, A.U.E. tubing. Landed at 3665 ft.
11. Well completed 11-20-74.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
