Set 4-1/2" K-55 casing at 3745' with 840 sacks Class "B" 50:50 Poz, 6X Gel, 2 pounds medium Tuf Plug per sack and 50 sacks Class "B" Neat. Circulated 20 barrels of cement.

Instructions
