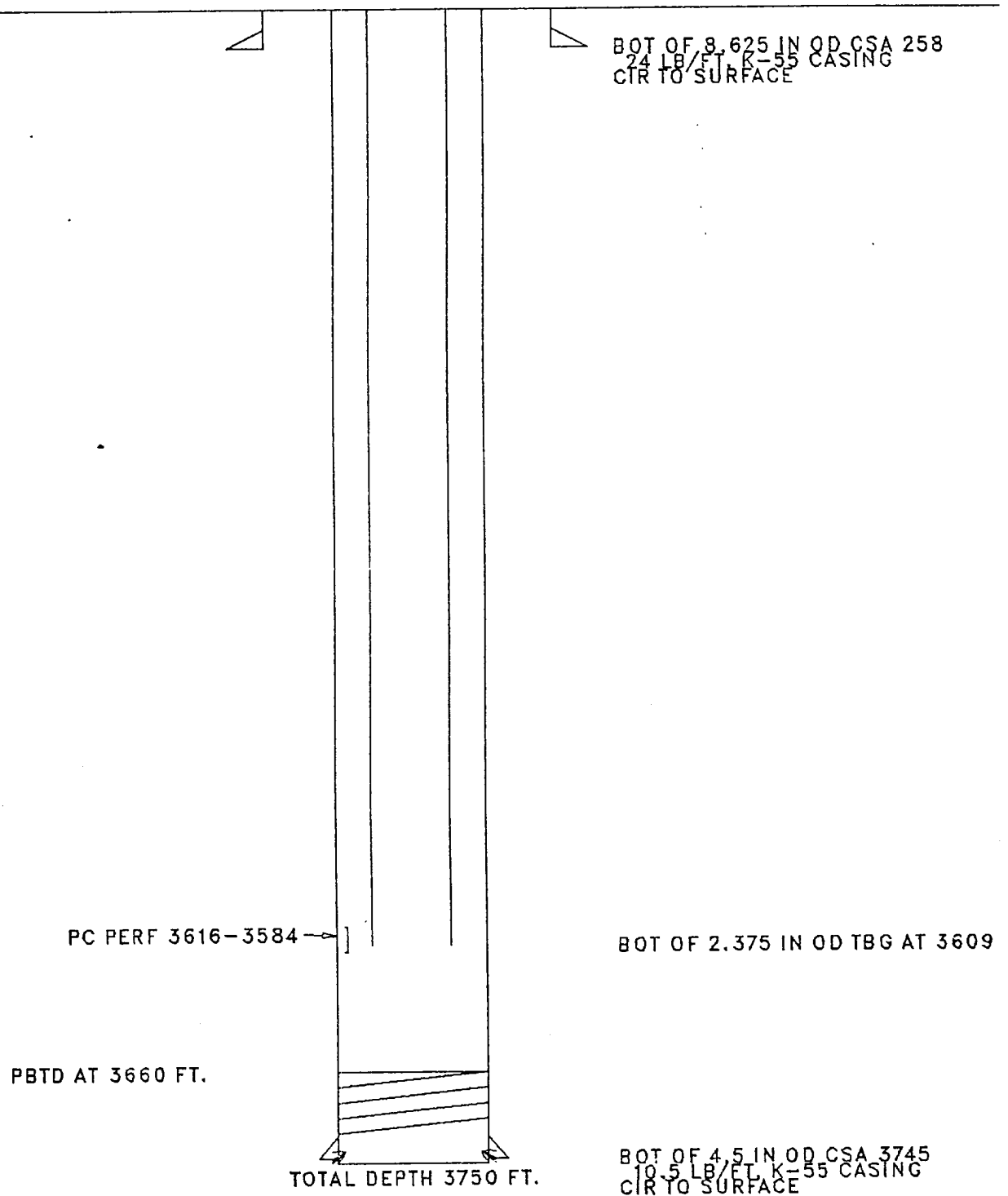
PXA Procedures
Jicarilla Apache 102 #20
10G-26N-04W

1. Check location for anchors. Install if necessary. Test anchors.
2. MIRUSU. NDWH. NUBOPE.
3. POOH with 2 3/8" tbg. RIH with tbg and cement retainer/pkr. Set retainer/pkr at 3500'. Squeeze PC perfs at 3616-3584 with 26 sx class B cement. WOC. Tag top of cement.
4. Spot cement plugs as follows:

3500' to 3000'	57sx class B cement
1500' to 1300'	23sx class B cement
258' to surface	29sx class B cement

Load hole with 9lb mudd/poz water in between plugs.
5. NDBOPE. Cut off casing and wellhead. Install PXA maker according to BLM or State requirements.
6. Turn over to John Schwartz for reclamation.
7. Rehabilitate location according to BLM or State requirements.
