Drilled 7-7/8" hole to 4027'. Set 4-1/2" J-55 casing at 4026', with 825 sx Class "B" 50:50 Poz, 6% Gal, 2# Medium Tuf Plug per sx. Circulated good cement.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
