The above-named company is hereby authorized to commingle South Blanco Pictured Cliffs, Blanco Mesaverde, Tapacito Gallup Associated, Undesignated Gallup and Basin Dakota Pool production from the following 4 wells shown on Exhibit "A" attached hereto.


Production shall be allocated to each well by separately metering individual well production by allocation meters and multiplying individual fractional contributions of the sum of these meters by the central sales meter volume.

**FURTHER:** The operator shall notify the Aztec District Office of the Division upon implementation of the commingling process.

**NOTE:** This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

**NOTE:** This gathering system shall be known as the Jicarilla CDP with one master sales meter located in Unit Letter "E" of Section 8, Township 26 North, Range 5 West, Rio Arriba County, New Mexico.
