10/23 RU pulling unit. ND wellhead. NU BOP. POOH w/tbg. TIH & tag at 5510', POOH.

10/25 TIH w/bit & drill collars. Clean out from 5510' -5530'. Stuck bit. Freepoint tbg. Back off at 5440'. POOH.

10/27 TIH w/drill collars & jars. Screw back into collars. Jar on tbg w/no success. Back off at 5440'. POOH.

10/29 TIH w/production tbg. ND BOP. NU wellhead. RD pulling unit.

In July a workover to added MV pay, but was not successful in DHC the MV and Dakota. Approval (DHC-2949) was received to DHC these zones in August 2001. The workover resulted in temporary abandonment of the Dakota after several unsuccessful attempts to drill up the CIBP at 5500' located above the Dakota perforations 7041-7269'. Therefore, all current production will be allocated to the Mesaverde completion.
