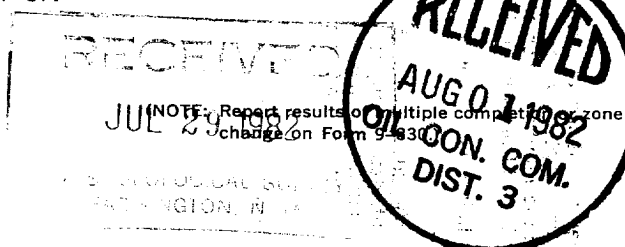

Instructions
