Objective is to abandon the Mirbrava and recomplete to the Mesa Verde. (General Procedure below)

1. Set a CIBP topped w/ 35' CMT via wireline @  $\pm 7,070'$  (100' above the uppermost perf. @ 7,170')
2. Perforate / Acidize / Frac the Mesa Verde from 5,500' to 5,900'
3. Recover load and Flow test.
4. Obtain C/A and submit C-104 prior to production.
5. Put on production.
