Union Texas Petroleum wishes to advise that a 8-1/2" hole was drilled to 3720' KB. Run 7", 23#, K-55 casing to 3719' KB, cementing to surface with 300 sxs (861 cu.ft.) 65/35 POZ containing 12% gel, 12-1/4# gilsonite/sk, and 10# salt/sk, tailed by 100 sxs (118 cu.ft.) Cl "B" with 2% CaCl2. Did not circulate to surface. Top of cement 2600' KB by temperature survey dated 10/16/86. Drill 6-3/4" hole with gas to 7850' KB. Run 4-1/2", 10.5#, K-55 production liner from 3506' to 7850' KB. Cement into intermediate casing with 55 sxs (158 cu.ft.) 65/35 POZ with 12% gel and 12-1/4# gilsonite/sk, tailed by 412 sxs (647 cu.ft.) 50/50 POZ with 4% gel, 6-1/4# gilsonite/sk and 10# salt/sk. Circulate 14 bbls (79 cu.ft.) of cement off of liner hanger.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
