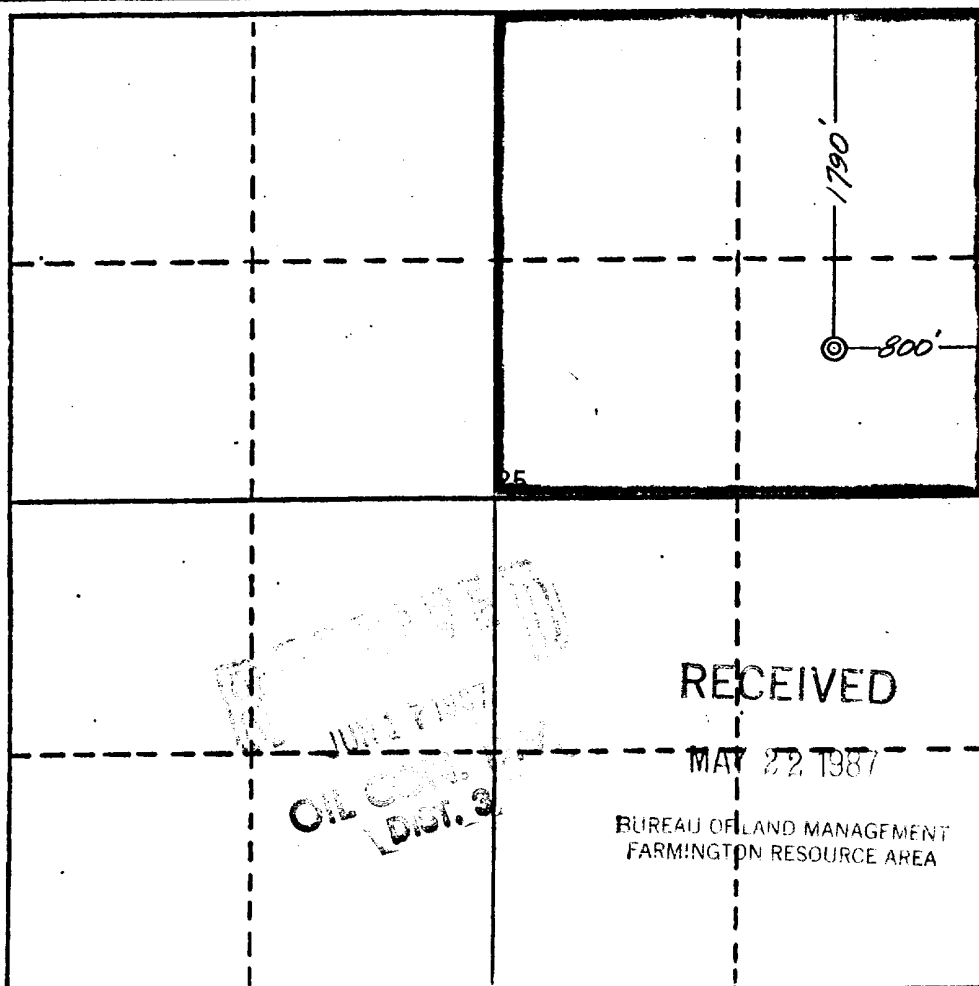

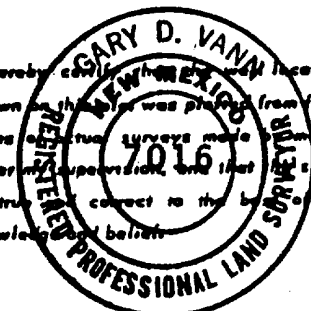

- A. Cuttings, drilling fluids, and produced fluids will be contained in the reserve pit and be allowed to evaporate. The reserve pit will be fenced on 3 sides and the 4th side will be fenced upon removal of the rig. Sanitary facilities and a steel mesh portable trash container will remain on location throughout drilling operations and will then be removed to a designated disposal area. The well site will be properly cleaned up upon removal of the rig.

8. Ancillary Facilities

A. None of these facilities will be constructed.

9. Well Site Layout

A. - C. Cross-sections etc. - see Exhibit D. Exact location of rig related equipment will be determined when Amoco contracts a drilling rig; however, all this equipment will be contained on location. The location diagram reflects actual area of well pad. Total disturbed area will vary due to cut and fill slopes.

A. Restoration of the surface will be conducted after the reserve pit has dried. The pit will then be cleaned up and back filled and the entire disturbed area will be recontoured. The topsoil stockpile will then be uniformly placed over this area and reseeding of the site will be carried out as instructed by the appropriate management agency.

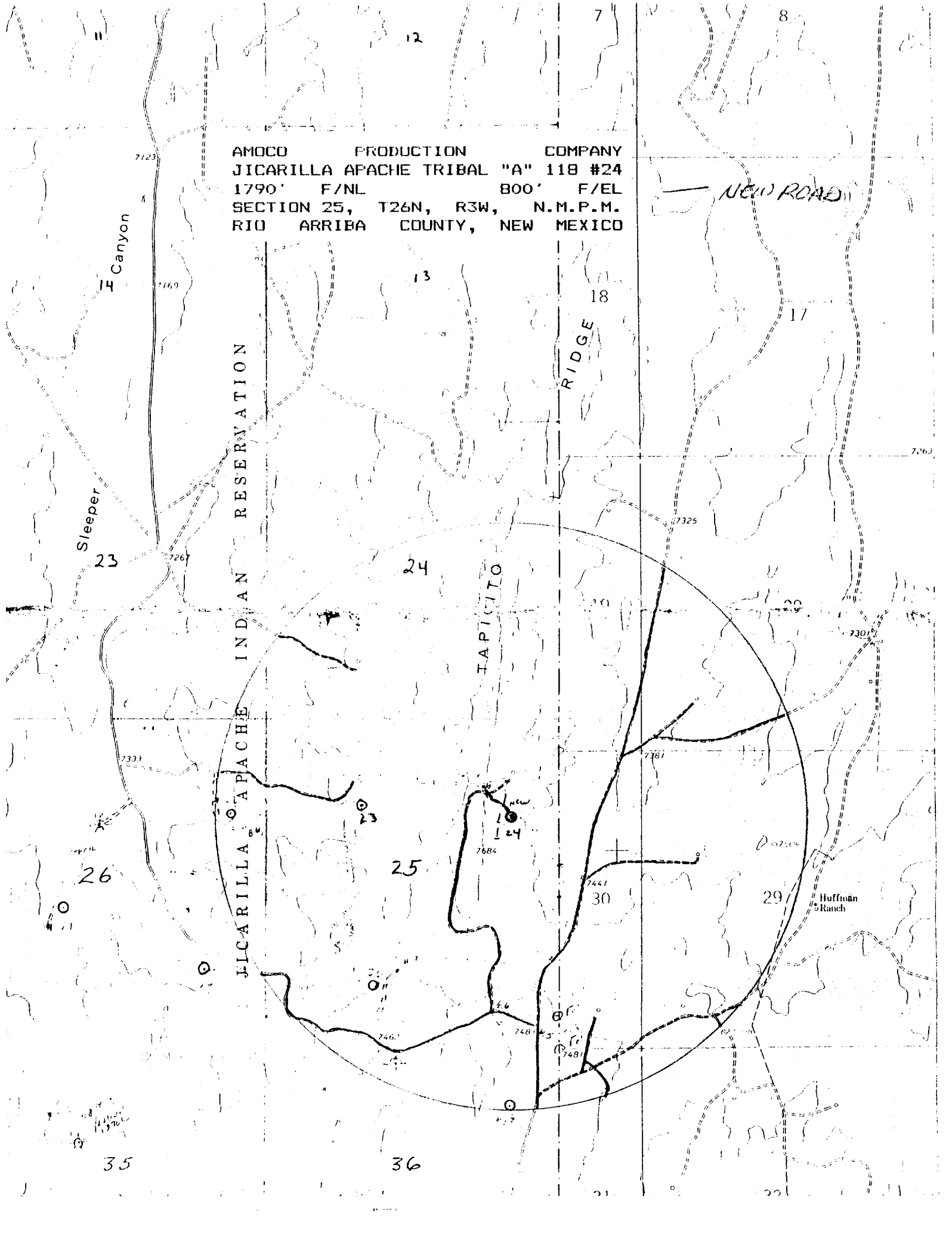
