17. DESCRIBE PROPOSED OR COMPLETED OPERATIONS. (If well is directionally drilled, give subsurface locations and measured and true vertical depths for all markers and zones pertinent to this work.)

Union Texas Petroleum desires to re-enter this well, sidetrack and redrill to 7750'. The work will be completed as follows:

1. Move in rotary tools.
2. Drill out cement retainer at 3300'. Drill 6-1/4" hole to 3550' (10' below intermediate casing depth).
3. Run 2° bent sub, attempt a kickoff while drilling 6-1/4" hole with gas. Kick off until a 8° deviation is achieved. Trip out.
4. Drill 6-1/4" hole to 7750' TD. Deviation surveys to be taken as needed or every 250'. Log well. Run 4-1/2", 11.6# liner from 7750' to 3250'. Cement liner with 535 ex (840 cu.ft.) 50/50 POZ with 4% cel, 6-1/4# oilsonite/sk, and 10# salt/sk.
5. Complete the well pursuant to original APD.
