Stan Phillips, being first duly sworn according to law, upon his oath deposes and says:

1. That he is Production Foreman of M W Petroleum
(Title) (Operator)
whose address is 2855 Southside River Road, Farmington, New Mexico 87401.

2. That MW Petroleum is the operator of a well drilled on land be-

longing to Steve & Eunice Stevenson, whose address is HCR 74, Box 80
(Landowner)
Lindrith, New Mexico 87029, said well being drilled to test for hydrocarbons and/or
carbon dioxide gas and described as the Bear Canyon No. 5, being located 1040
feet from the South line and 890 feet from the West line of Section 12,
Township 26N, Range 2W M, NMPM, Rio Arriba
County, New Mexico.


3. That said well was drilled to a total depth of 7658' feet, and that cas-
ing has been set and cemented as follows:

10 3/4" @ 373' w/372 sx cmt --- Circ cmt to surface.
7 5/8" @ 6639' 1st w/290 cuft cmt. 2nd stage thru DV tool @ 3972' w/560 cuft, 5" liner
f/6318' to 7658' w/385 cuft cmt.

4. That operator and landowner have made an agreement whereby operator
(is) (is not) to back fill pits, level location, and clear it of all junk. The agreement
further provides that operator is to plug said well back to a plugged-back total depth of
2441 feet and transfer well to landowner for his use as a water-well. Operator will
leave casing in the well as follows:

10 3/4" casing and 7 5/8" casing cut off 2' below surface.

5. That when operator has complied with the provisions of Paragraph 4 above
it will so notify the Oil Conservation Commission of the State of New Mexico on Com-
mission Form C-103, together with a signed statement from the landowner that the
provisions of Paragraph 4 above have been complied with to his satisfaction.
