Dear Mr. LeMay:

This is a request for administrative approval for an unorthodox gas well location in the Ballard Pictured Cliffs Pool.

It is intended to locate the Meridian Oil Inc.'s Donohue #3 at 2235' from the South line and 1480' from the East line of Section 7, T-25-N, R-7-W, Rio Arriba County, New Mexico.

Extremely rough terrain in the form of steep cliffs makes it impossible to build an orthodox location in the southeast quarter of this section.

A copy of this application is being submitted to all offset operators by certified mail with a request that they furnish your Santa Fe office with a Waiver of Objection, and return one copy to this office.

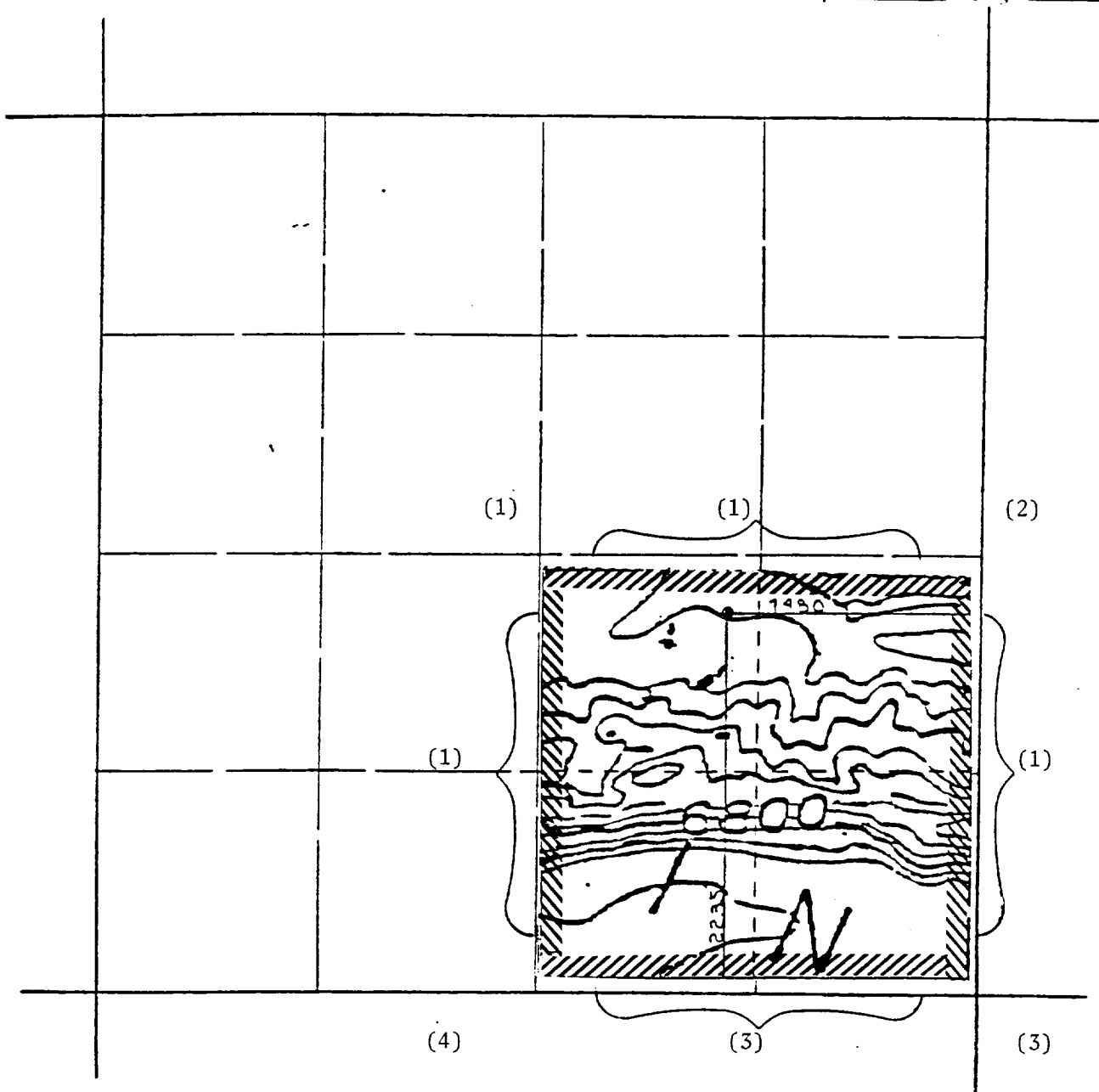

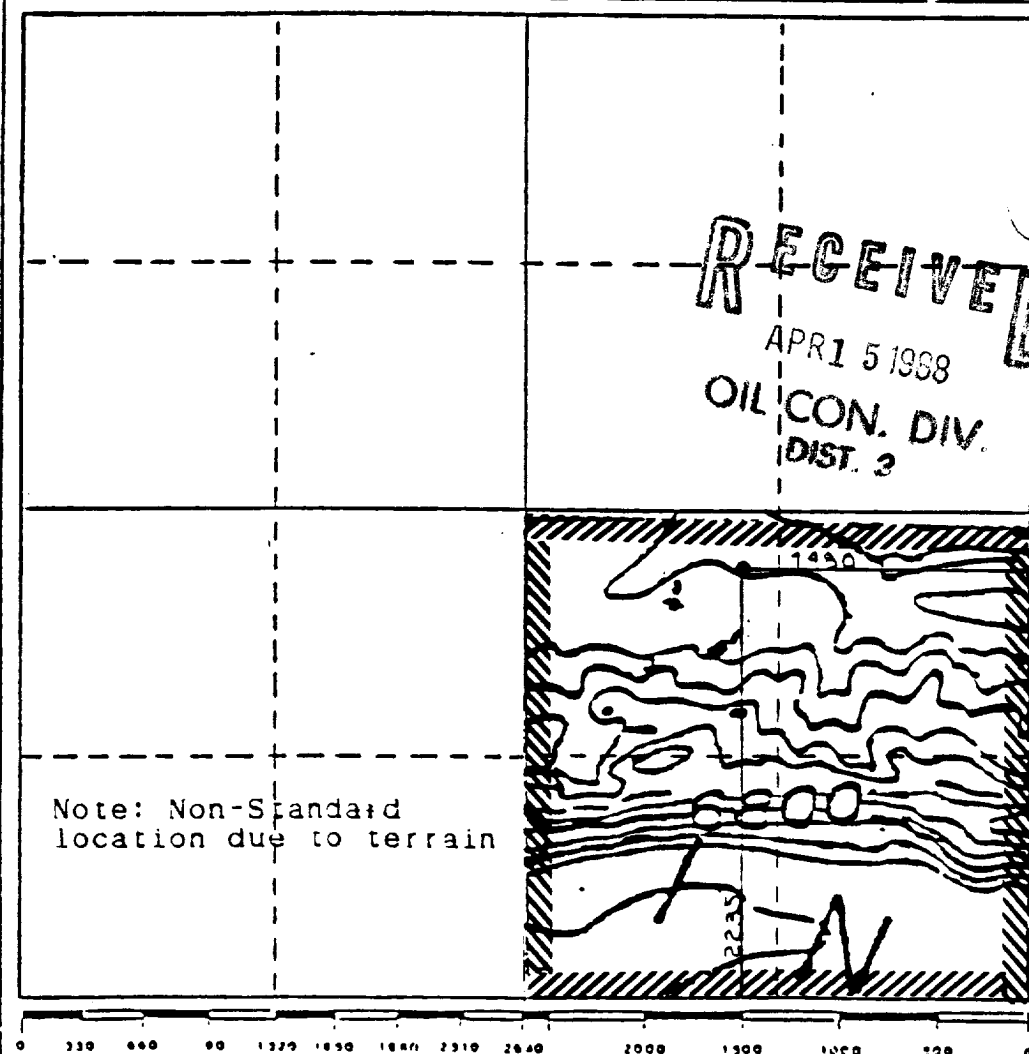
