As per conversation of Mike Rainwater with Mr. Charles Perrin w/NMOCC, Louis Dreyfus Natural Gas Corp. will monitor well as follows:

1. Open bradenhead to atmosphere for one (1) hour and estimate the volume of water discharged while monitoring and recording casing pressure during flow period.
2. Shut-in bradenhead valve and monitor and record bradenhead and casing pressure for 15 minutes. Report results to BLM.

We will notify the Farmington office of the BLM 24 hrs prior to flow test.
