B. Pressure test 5-1/2" OD casing to 3500 psi.
C. Perforate Fruitland Coal zone 2134 to 2144' and 2151 to 2154' with 4 SPF.
D. Stimulate Fruitland coal zone with \pm 27,000 gals. 70 quality N₂ foamed 20# gel, 5000# 40/70 sand, 45,500# 20/40 sand.
E. Flow well back.
F. Run \pm 2134' 2-3/8" OD, 4.7#, J-55 tubing for production.
G. Produce well.
