Rincon Unit #302 was originally permitted and drilled as a Basin Dakota/Largo Gallup well. The well was spudded July 6, 1994 and TD'd at 7,612' July 18, 1994. The well was logged and 5-1/2" production casing was run and cemented. After evaluating the logs, UNOCAL finds that the Gallup formation has no production potential and any perforating/stimulation in the Gallup is not warranted. Therefore, UNOCAL wishes to complete the well in the Dakota/Mesa Verde Formations.

Application has been made to the State of New Mexico, Oil Conservation Division for an unorthodox Dakota/Mesa Verde location for this well.

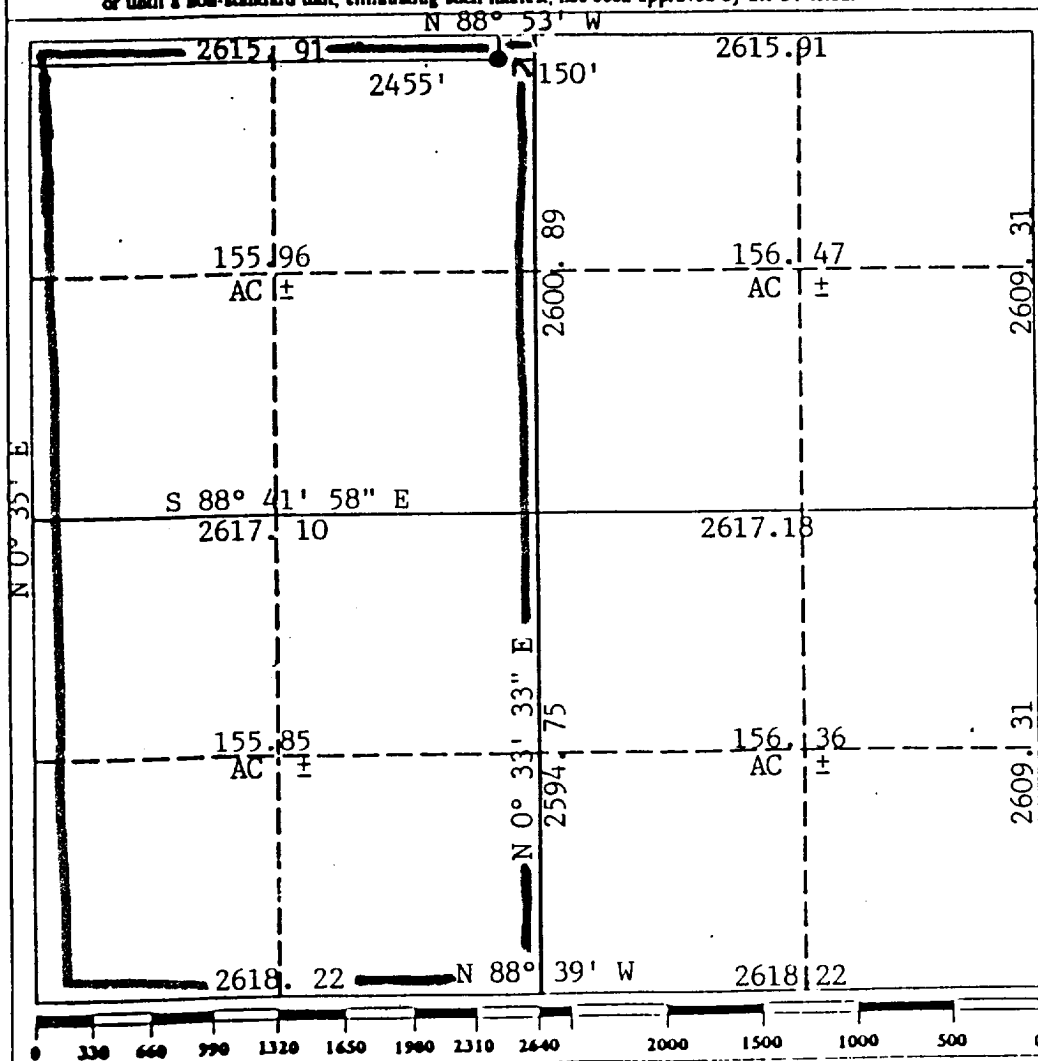
