The subject well was initially permitted as an Otero Chacra development well and 4-1/2" casing was cemented at a total depth of 3475' on 10-5-97. We now propose to complete the South Blanco Pictured Cliffs interval at the approximate depths of 2278-2342' in addition to the Otero Chacra at approximately 3170-3399'. An application to downhole commingle both zones will be subsequently submitted for approval. A C-102 for proposed South Blanco Pictured Cliffs completion is attached.



