Cement with 105 sks of Class B, 50/50 POZ, w/ 4% Gel & 0.3 FL-52 & 0.3% CD-32 & 2% KCl, 8#/sk KoL Seal. Followed by 200 sks of Class H w/ 0.7% BA-56, 0.3% CD-32, .25#/SK Cello Flake. Displaced with 30 bbls of H2O/mud, muddy returns, full returns, no cement returns. Floats held. Bumped plug @ 5:30 p.m. on 01-14-98, w/ 1250 PSI. Had good/complete returns throughout job.

01/14/97 STAGE 2 Stage collar depth 5927.57', manufacturer Weatherford/Gemco. Cement with 380 sks of 50/50 POZ w/ 4% Gel, 0.3% FL-52, 0.3% CD-32, 2%KCl, 8#/sk KoL Seal. Followed by 50 sks of Class B w/ 6.25 lb./SK Gilsonite. Displaced with 50 bbls of H2O, w/muddy and full returns. No cement returns. Stage stool held. Bumped plug @ 10:25 p.m. on 01-14-98 w/ 1250 PSI. Had good/complete circulation throughout job.

01/15/98 STAGE 3 Stage collar depth 3665.71', manufacturer Weatherford/Gemco. Cement with 460 sks of 65/35 POZ w/ 8% Gel, 2% CaCl2, 8#/sk KoL Seals. Followed by 50 sks of Class B w/ 6.25#/sk Gilsonite.
