07/24/02 TIH with CIBP, set @ 5500'. Test casing to 3000 psi - ok. Perforate Cliff House 5307' - 5414'. Acidize w/ 1000 gals 15% HCL

07/25/02 Frac Cliff House w/ 68,277 gals 60Q foam and 70,000# 20/40 sand. Flow back to pit for cleanup.

07/26/02-07/29/02 Continue to flow back after frac.

07/31/02 TIH. Clean out to 5500' with air mist.

08/01/02 TOH and lay down DC. TIH with 2-3/8" tubing, land @ 7813'. ND BOP. NU wellhead. Return to production.
