Followed with 100 sks 50/50 Poz, 2% gel, 10#/sk gilsonite, 1/2#/sk flocele and 2% CaCL2. (900 cu. ft.) Plug down @ 1:00 am 12/30/99. Circ. 18 bbls cement to surface. WOC. Test casing to 1200 psi - OK.
