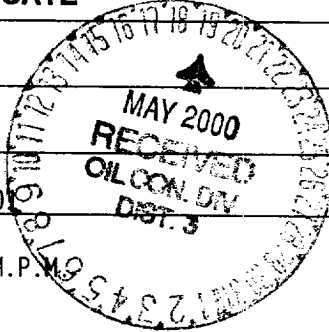

Cement with 450 sks 65/35 poz "B", 2% gel, 10#/sk gilsonite, 1/2#/sk flocele, 2% CaCl₂, followed with 100 sks 50/50 poz "B", 2% gel, 10#/sk gilsonite, 1/2#/sk flocele, 2% CaCl₂. (937 cu. ft.). Plug down at 12:30 pm 5/8/00. Circ. 10 sks cement to surface. WOC. Test casing to 1200 psi - OK.
