Well is currently permitted to a total depth of 6,850'. We are changing the total depth to 4,800 with primary objectives of the Chacra and Mesaverde. Following is the procedure change:

1. Drill 11" hole to \pm 350'. Set 8 5/8", J55, 24# surface csg at \pm 350'. Cement w/250 sks Class H cement to surface.
2. Drill 7 7/8" hole to \pm 4,800. Set 5 1/2", LT&C, 11.6# production csg at \pm 4,800'. Cement w/550 sks Class H cement to surface.
