

4-2-01 ran 9 jts of 9 5/8", 36# J-55 ST&C csg, set @ 384'. Cemented w/160 sks Type III cement w/2% CaCl2. Circulated 6 bbls of cement to surface. Wait on Cement 18 hrs. commnced drilling.

4-10-01 ran 50 jts of 5 1/2", 17#, N-80 LT&C csg, set @ 4,805'. Cemented first stage w/201 sks of 35/65 poz, type III cmt w/6% gel. Cemented 2nd stage, lead w/277 sks of 35/65 poz type III w/8% gel, tailed w/50 sks of type III cement w/2% CaCl. Bumped plug, float held, circulated 10 bbl cement to surface. Rig released, waiting on completion unit.
