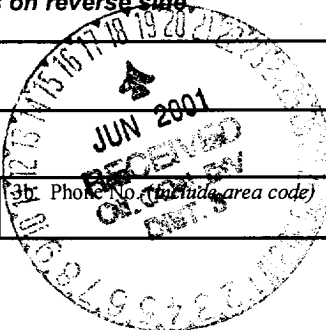

Plug down @ 4:15 pm 05/17/01. Did not circulate. RD Halliburton. ND BOP. WOC. RU BWWC, ran temperature survey, found good cement @ 3840'. Will perforate @ 3800' and cement to surface.
