11-6-95 TIH to 2458'. Plug #1: pump 35 sx Class "B" @ 2203-2458'. PT csg to 500 psi, OK. TOO H to 2040'. Perf 4 sqz holes @ 2040'. Unable to establish injection. SDON.

11-7-95 Plug #2: pump 37 sx Class "B" cmt inside csg @ 1811-2090'. TOO H. Perf 2 sqz holes @ 450'. Could not establish circ out bradenhead. Plug #3: pump 120 sx Class "B" cmt down csg. Circ stopped.
