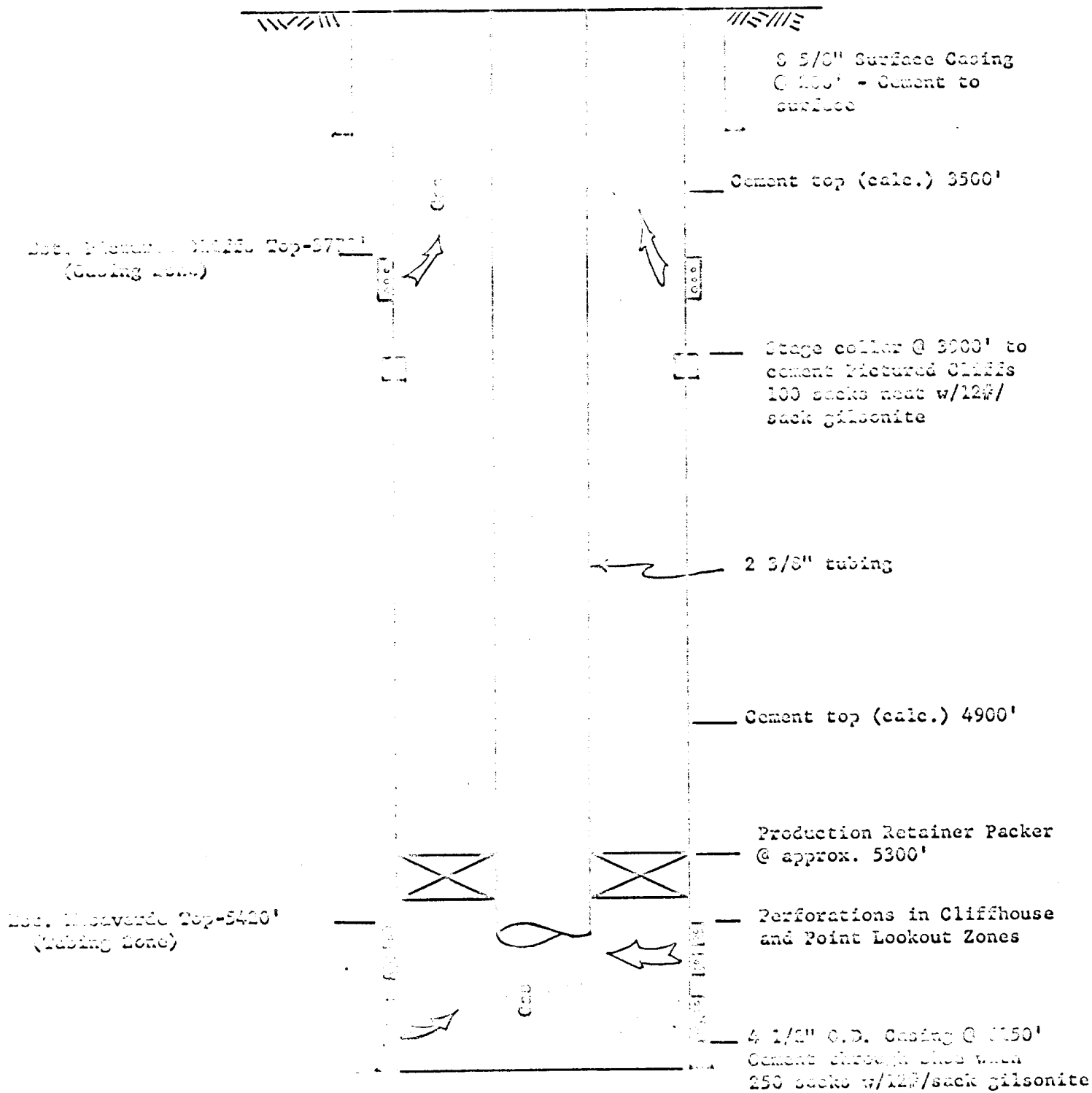

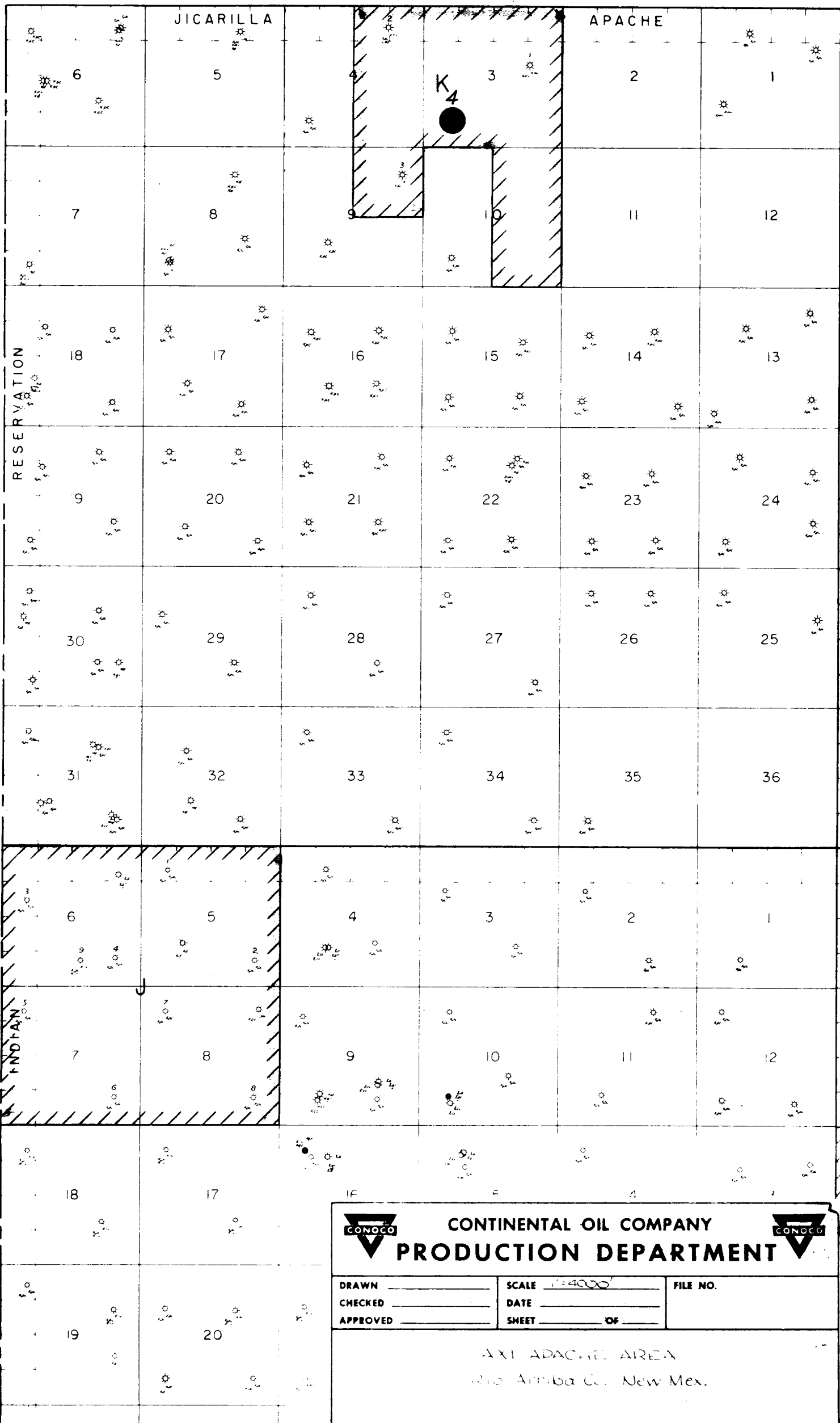
SCHEMATIC DIAGRAM
