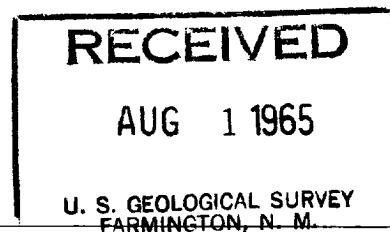

Spudded 2:00 AM 7-24-65. Drilled to TD 322. Cemented 9-5/8" OD 32.30# H-40 Casing at 321' with 225 sacks common cement. Last 100 sacks cement contained 2% calcium chloride. Plug down at 4:30 PM, 7-24-65

Tested casing with 800# water pressure for 30 minutes with no decrease at 4:30 PM, 7-25-65

Please note that elevation is 5' higher now than when reported on Notice of Intention to Drill. Ground surface at hole was raised that much in the levelling of the location

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
