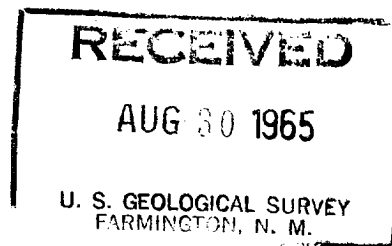

The electric logs run in this well indicate possible Mesa Verde gas production. It is therefore proposed to test the Mesa Verde sands by perforating and fracturing 5146-52, 5196-5208, 5258-64, 5295-5310 and 4658-4672. If commercial gas production is developed from these sands the same plans originally proposed for separating the Pictured Cliffs and Dakota is proposed for separating the Mesa Verde and Dakota

Instructions
