Pulled rods. Spotted cement plug from 5418' to 5318'. Pulled 2" tubing worked 5-1/2" casing. Rigged up blue jet, perforated from 1730' - 1731' w/4 shots.

Ran 2" tubing, spotted cement plug from 1731' to 1581'. Pulled 2" tubing, shot 5-1/2" casing off at 1025'. Spotted cement plug from 1098' to 900', 73' inside and 125' above 5-1/2" casing stub. Total 5-1/2" casing pulled 32 joints 1029'.

Spotted 10' cement plug in surface casing. Installed dry hole marker.

Completed P & A 7-1-71.
