**DETAILS OF WORK**

12 1/4" hole was drilled to 240'. 9 5/8" 32.75 H-40 casing was set at 239' and cemented with 200 sacks neat cement. Plug pumped down 6:00 A.M. 7/6/57. Approximately 25 sacks cement was circulated back to surface. Plug drilled 6:00 A.M. 7/7/57. Jobs tested with 500 p.s.i. with no pressure drop. 227.54' of casing was left in hole.
