It is our intention to drill well No. 2 to approximately 5500' to test the Gallup formation. Our casing program is as follows:

300' of 10-3/4" OD casing, 32.75# EM N-40, cemented with 150 sks. reg. cement - circulated.
5500' of 5-1/2" OD casing, 14# SS J-55, cemented with 250 sks. reg. cement.

The designated drilling unit is the NE 1/4 SE 1/4 of Section 33-29N-10W, San Juan County, New Mexico.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

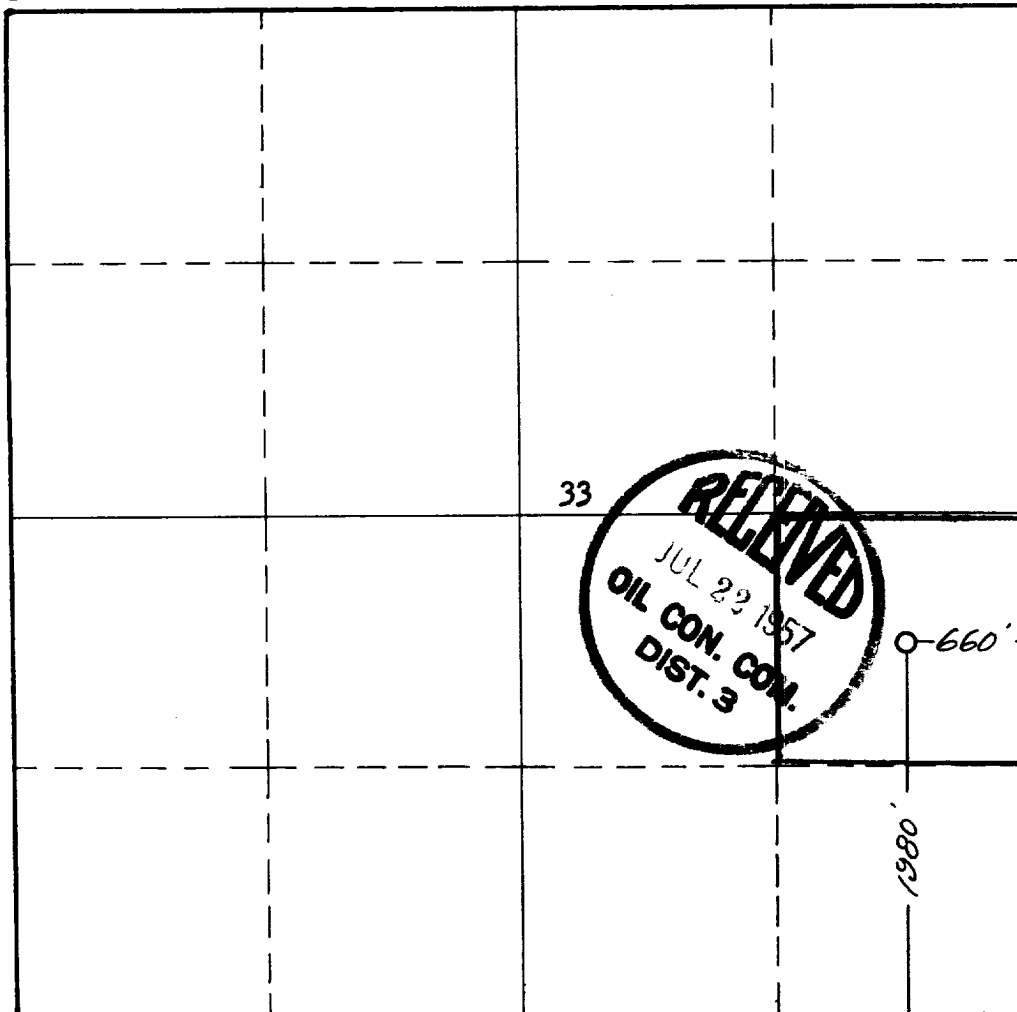

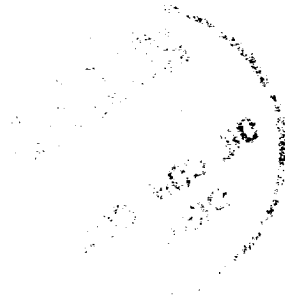
