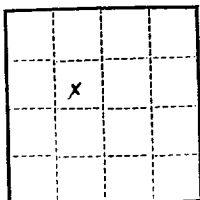

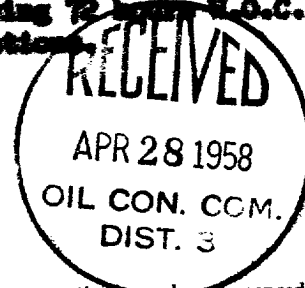

DETAILS OF WORK

We intend to drill a 12 1/2" hole to approximately 250 feet and set 9 5/8" 32.3# H-40 casing with sufficient cement to circulate, allowing 24 hours W.O.C. time. An 8 3/4" hole will be drilled to approximately 500 feet to test lower Gallup and 5 1/2" 14# J-55 casing will be set with 350 sacks, allowing 72 hours W.O.C. time. All casing jobs will be tested according to regulations.



I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

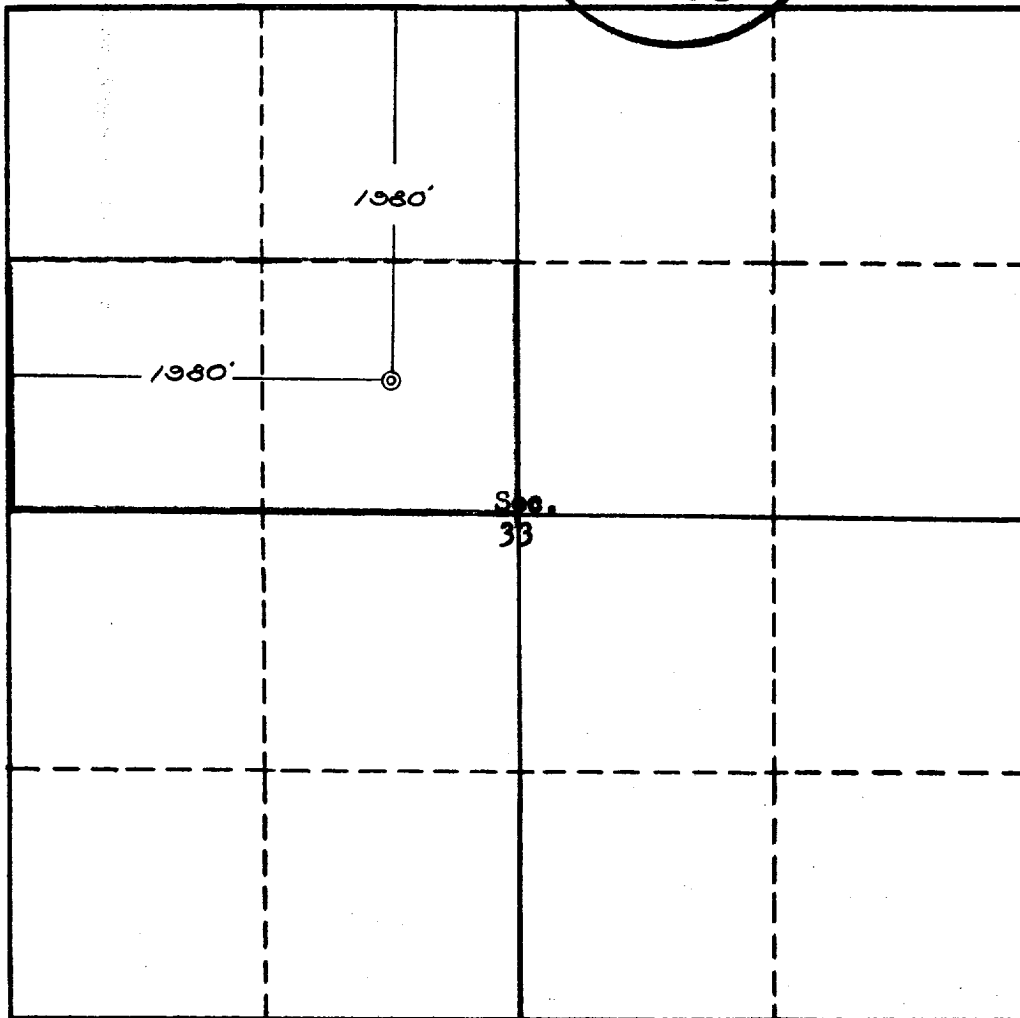
